Introduction

This plan demonstrates the adaptations and reasonable adjustments the school will make to allow accessibility for all. It acknowledges the limitations of the building and the significant costs that would be needed to bring the building in line with current guidelines.

Description of the school

The main school building is designed on a split level with 4 sets of staircases giving access between the main hall and the classrooms within the main building. Older pupils are educated in newly built classroom blocks and the youngest pupils are educated in a separate purpose built Foundation Classroom. The old portacabins have been retained to house The Learning Hub and before/after school clubs. Separate playgrounds are found on the lower and upper levels of the site with stepped access between the two.

This plan identifies the school's targets on a year by year basis and what has been achieved/what needs to be achieved in order to meet the targets.
